TOURNAMENT RULES

1. This is a handicap tournament: 220 scratch, 90% handicap.
2. Entrants must use their highest final USBC sanctioned league average from the 2008-2009 season of 21 games or more. If no 2008-2009 season average, including summer leagues then entrant must use her 2008 – 2009 highest current average of 21 games or more as of November 29, 2009. A bowler must use her highest average whether bowled as a regular team roster member or substitute. If an entrant does not meet any of the above average requirements, then they must bowl scratch. If the entrant's highest sanctioned league average is from other than the Dayton WBA, she must submit written verification with her entry.
3. No bowler will be permitted to bowl more than once in this tournament. All entrants must hold a current season Adult USBC card and be a current member of the Dayton Area 600 Club.
4. USBC Rule 319a (2) "10 pins or higher" and Rule 319c "15 or more pins increase in average" **will not apply**.
5. USBC Rule 319a (3) "Bowler's responsibility for verifying own average" **will apply**.
6. USBC Rule 319d "Reporting prize winnings" **will not apply**.
7. All bowlers wishing to bowl together must send their entries together in the same envelope.
8. All entrants must check in 30 minutes prior to squad time and present her USBC and 600 Club cards.
9. Current Dayton Area 600 Club dues (\$2.00 if current or \$6.00 if not current for past 3 years or more) must accompany entry unless already paid.
10. Walk-Ins allowed upon lane availability – All Walk-Ins must report 30 minutes before shift time to begin.
